- 1. The DSSSB vide its advertisement no. 02/21 dated 12/05/2021 with closing date 24/06/2021 and notice to the advertisement no. 02/21 dated 23/06/2021 had advertised 12 vacancies (EWS-01, UR-07, OBC-03, SC-01, including OH-01) for the Post of Head Clerk under post code 46/21 in Delhi Urban Shelter Improvement Board (DUSIB).
- 2. The normalized marks obtained by 23278 candidates who duly appeared in written examination held on 21/02/2022, 22/02/2022, 23/02/2022, 24/02/2022, 25/02/2022 (1, 2, 3 shifts) and 27/02/2022 (2nd and 3rd Shift) have been uploaded on Board's website. Candidate can view their marks by logging into their account in the OARS Module www.dsssbonline.nic.in
- 3. Based on the performance in Tier-I written examination (online mode), out of these 23278 candidates, total 150 (One Hundred Fifty) candidates (EWS-12, UR-78, OBC-37, SC-11 and OH-12) as detailed below, have been provisionally shortlisted to appear in Tier II examination (fixed, 150, as per policy of the Board) subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application forms. The candidates have been shortlisted proportionately [88 candidates for 07 vacancies in UR category, 38 candidates for 03 vacancies in OBC Category, 12 candidates each for 1 vacancy in EWS category and SC category including 12 candidates for 1 vacancy of OH sub-category (UR-10, OBC-1, SC-1)].
- 4. The shortlisted candidates shall be called for Tier-II examination separately

- 5. Only those candidates have been considered in OBC Category who has declared that they had obtained their caste certificates from Delhi State in their online examination form.
- 6. Since documents have not been called from the candidates along with the application forms as such detailed scrutiny regarding eligibility has not been carried out, and therefore, mere inclusion of names in the list of candidates qualifying for appearing in Tier-II examination does not entitled them any right over the post.



- 7. Reserved Category candidates who have obtained marks above or equal to the last shortlisted UR Candidates have been shortlisted against UR vacancies and their final selection to the post shall be considered in UR category, subject to availability of vacancies, otherwise for selection in their respective category.
- 8. As per the Board Notice dated 26/04/2013 the minimum qualifying marks in two Tier written examinations for UR Category Candidate is 40%, for OBC Candidate is 35% for SC/PH candidate is 30%.
- 9. While every care has been taken in preparing the result, DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
